## What is HRC-PAC?

The Harrisburg Regional Chamber Political Action Committee is multi-candidate, bi-partisan voice for business in Central Pennsylvania that complements the Harrisburg Regional Chamber's exceptional Government Relations program. We raise contributions to support Elected Officials that understand the business issues facing Chamber members

## Why does the Chamber have HRC-PAC?

HRC-PAC is designed to take our Government Relations program to the next level by supporting candidates that understand the needs of the free market and private enterprise systems, and the Harrisburg Regional Chamber's legislative agenda. Our PAC supports the campaigns of pro-business candidates seeking public office.

## How does HRC-PAC benefit Chamber members?

Your contribution sends a strong message for your business' needs and priorities to candidates that support issues along with the Chamber.

## How does HRC-PAC choose candidates to support in elections?
